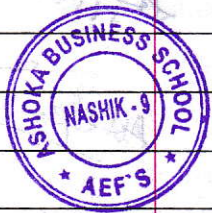
Following points were discussed in the meeting -

2. To follow and act according to the Law of Anti ragging Act-UGC Regulations on curbing The Menace of ragging in Higher Educational Institutions and as per the Regulation 6 of it about the measures for prevention of ragging at the Institutional level. It lays down the steps an Institution has to follow during the admission and registration process. A student during the admission process has to file an e-affidavit along with his/her father/guardian/parents.

Also the Institution has to publish the names and contact numbers of Anti-ragging Committee of the university.

3. To Conduct the awareness programme among the Student  
The Institute decided to take stringent action against students involved in Ragging based on the recommendations made by Hon. Supreme Court, UGC and Govt.

It was further decided to provide enough publicity in the Institute against such a barbarism through awareness activities in the institute. It was decided to show the






anti-ragging videos, short film to the students.

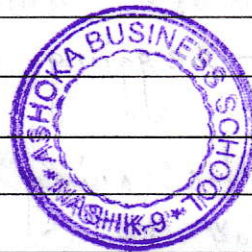
4. To advice the students to communicate their parents if any sort of ragging.

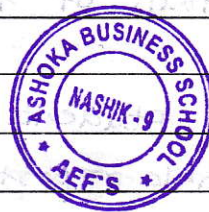
The following points were discussed in the meeting :-

4) Appeal for nominations to the Anti-Ragging Committee.

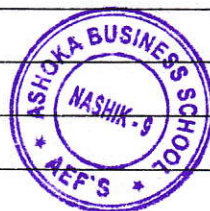
