# **Divyangjan (Persons with Disabilities) Policy**

#### 1. Policy Statement

Ashoka Business School, Nashik, is committed to creating a comprehensive and inclusive environment for individuals with disabilities. ## 2. Objectives of the Policy

### 3. Definition of Disability

Disability encompasses motor and sensory limitations (e.g., mobility, vision, or hearing impairments), chronic illnesses and syndromes, invisible disabilities (e.g., psychological and emotional disorders, learning disabilities), and other conditions such as heart disease, diabetes, asthma, arthritis, epilepsy, Acquired Brain Injuries (ABI), and Acquired Immune Deficiency Syndrome (AIDS).

#### 4. Qualified Person with Disability

A "qualified individual with a disability" refers to a person who meets the academic and essential requirements for participation in any institute program or activity, including employment, training, work assignments, and promotion. Necessary accommodations and relaxations shall be provided as per government regulations.

### 5. Accessibility Policy

The institute is dedicated to creating a disabled-friendly campus by ensuring accessibility and reasonable accommodations for each person with a disability. The following principles will be strictly observed:

- All programs and activities must be accessible.
- Provide accessible textbooks and study materials.
- Ensure representation of all types of disabilities as per the Rights of Persons with Disabilities Act, 2016, and other relevant government regulations.
