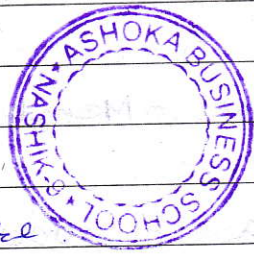
1. Review of last minutes of meeting:



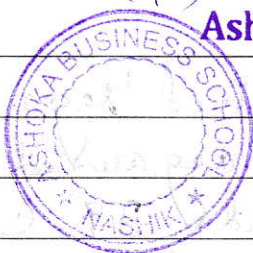
