This MEMORANDUM OF UNDERSTANDING is made and executed on this 25th Day of August 2020 at Nashik.

BETWEEN

Ashoka Education Foundation's, Ashoka Business School, an Institute affiliated to Pune University, having its office at: Urjayant Plaza, Near Suman Petrol Pump, Rane Nagar, Mumbai-Agra Highway, Nasik - 422009 through its Director Dr. D. M. Gujarathi. Hereinafter referred to as "THE PARTY NO. 1" (which expression shall unless it be repugnant to the subject or context thereof, be deemed to mean and include the school its office bearers, administrators, successors and assigns) of the FIRST PART.

AND

COGNIFRONT, NASHIK an Establishment registered in year 2008 under the Maharashtra Shops and Establishments (Regulation of Employment and Conditions of Service) Rules, Having Its Registered Office at Trishala Hsg. Society, Behind Mahalaxmi Talkies, Panchvati, Nashik, represented by Its Technical Director, Dr. R. S. Tiwari. Hereinafter referred to as "THE PARTY NO. 2" (which expression shall unless it be repugnant to the subject or context thereof, be deemed to mean and include the legally constituted signatories, heirs, representatives assignees, successors) of the SECOND PART.

WHEREAS Cognifront, Nashik, is desirous of arranging training programmes For Business Analytics lectures.




AND WHEREAS, Cognifront, Nashik is desirous of making its know-how and other related material and services commercially available to the Ashoka Business School for setting up and running the said trainings.

NOW, THEREFORE, in consideration of the Authorized Purpose, disclosure of Confidential Information, and any future business relationship between the parties, it is hereby agreed with below mentions terms as follows:

Purpose of this MOU:

1. To enhance the Industry-Institute Interaction.
2. To learn real time case studies in Business Analytics.
3. To connect industry-academia.







Deliverables by Cognifront, Nashik:

1. This MoU is under the supervision of Director/HOD, Ashoka Business School, Nashik.
2. As per the MoU, the Cognifront will establish the Center of Excellence in the campus of the Ashoka Business School, Nashik.
3. Under this center of Excellence, the following activities will be carried out by the Cognifront for Ashoka Business School students:
 1. Industrial visit for students & staff.
 2. Lectures by the experts from the organization
 3. Sponsorship for projects to students
 4. Participation in curriculum development
 5. Internship of students
 6. Expert guidance on lab development
 7. Expert guidance on skill enhancement
 8. Implementation of job oriented industrial training for the students and faculty.
 9. The fees of the training program would be shared as per rules stated in the Appendix to this MOU.
4. As per the MoU, the Ashoka Business School will help the Cognifront, Nashik by :
 1. To provide support for arranging the training program for Ashoka Business School students.
 2. To coordinate with Cognifront head and the ABS students for smooth functioning.

Both Parties Agrees that :


1. This MOU is valid for one academic year from the date of signing this MOU.
2. The **Ashoka Business School** has agreed to provide the entire infrastructure to training the students.
3. The **Cognifront**, agrees to provide all the training material required for the course.
4. The **Cognifront** agrees that fees should be collected by the Ashoka Education Foundation's Ashoka Business School, Nashik. The Ashoka Education Foundation will pay the per student training charges to Cognifront after successfully completion of training period.
5. **Cognifront** agrees to provide certification in association with the Ashoka Education Foundation's Ashoka Business School.
6. **Cognifront** agreed to complete training in schedule which has been decided mutually by both parties.
7. **Termination:** Both Parties may, terminate the MOU by giving prior and written notice of 1 month or before completion of any course which comes first, indicating its intention to terminate the MOU. Upon such termination, the ABS shall reserve




the right to take any steps as may be necessary, to ensure the effective transition of the course to a successor agency, and to ensure that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the Ashoka Business School. In case of termination both parties shall continue to provide their services to the students who have enrolled for that Academic Year. In any case student's interest shall be supreme.

8. In the event of any dispute or differences arising at any time between the Parties hereto as to the construction, meaning or effect of this Agreement or any clause or thing contained herein or the rights, duties, liabilities and obligations of the Parties hereto or breach thereof, the parties shall in good faith endeavor to resolve the dispute by mutual discussion. In the event, the parties are unable to do so, the matter will be settled by arbitration subject to the provision of the Arbitration and Conciliation Act, 1996 and as amended from time to time. The Parties agree and shall mutually endeavor to appoint a single arbitrator from Ashoka Education Foundation, within a period of thirty (30) days. The appointed arbitrator will be referred for resolution. The arbitration proceedings will be held at Nashik and only Nashik court will have Jurisdiction to resolve the matter.
9. This MOU shall be governed by the laws of Republic of India. Any dispute arising in connection therewith shall be submitted only to Nashik court have Jurisdiction to resolve the matter.

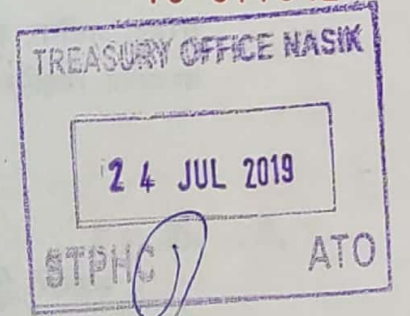


आंतरग्रंथालयीन देवघेव परस्पर सामंजस्य करार


३. दोन्ही संस्थामधील वाचनसाहित्याची देवघेव ग्रंथपालांच्या माध्यमातून करण्यात येईल.
